WHEREAS the Internal Affairs of AMSA states thoroughly that the Action Committees and Teams curate the Principles of the Association as part of their officer responsibilities; and,

WHEREAS the ACT leadership are the primary content experts of their designated programming areas; and,

WHEREAS the ACT leadership annually summarizes the Association Principles at the beginning and end of their terms; and,

WHEREAS AMSA has numerous marketing mediums at its disposal by which to educate and update the membership;

THEREFORE BE IT RESOLVED that the Internal Affairs, Section XXII. Review of Association Principles, be amended to read:

- A. The responsibility for review and revision of Association Principles is a general one falling to all the members of AMSA. However, it shall be a specific duty of the Action Committees and Teams to periodically review those Principles, which might apply to them, and assure they reflect the current evidence and the views of the membership.
- B. The Chairs of the Action Committees and Teams shall present to the Board of Trustees a short summary of sections of the Principles which apply to them and which will be reviewed during the year.
