Introduction

Healthcare professionals and medical students bring a unique public health perspective to the firearm safety conversation.

We deal intimately with the consequences of violence every day.

We know that research is the only way to understand the epidemiology and etiology of health issues.

We understand the importance of evidence-based solutions when caring for patients.

Across the nation, medical students in organizations such as our Medical Students for Gun Safety campaign are standing up. We are actively working to highlight the health impact of the epidemic of firearm violence in America and promote meaningful discussions about it.

We've got a unique stake in this issue, so it's up to us to make our voices heard.

We need to stand up for our patients and demand gun safety reform like never before. We must remind our elected officials that gun violence is a public health crisis and that the future physicians of this country will not stand on the sidelines. There must be regulations and interventions in place to prevent dangerous and deadly weapons to circulate freely in our communities. And in order to create more evidence-based regulations for the future, we must advocate for research now. Enough is enough!

For this August recess, it's up to us to call for action from our representatives in Congress. As future health professionals, it is our responsibility to continue to raise alarms about this public health epidemic and demand appropriate research funding to resolve this preventable problem.

1. Learn

What You Need to Know about Gun Safety Legislation

Thanks to a historic number of candidates running and winning on gun safety in the 2018 midterm elections, gun violence prevention has been a top priority in the House of Representatives this year. They have passed bills aimed at introducing background checks for all gun sales, stopping prohibited people from purchasing guns, providing critical protections for survivors of intimate partner violence, supporting extreme risk laws, and banning assault weapons and large capacity magazines.

Here's what MSGS will focus our advocacy efforts on for the August Recess, pushing the Senate to follow the House's lead:

Funding for Gun Violence Research: Gun violence is a public health and safety epidemic in America, killing close to 40,000 people every year. Every other phenomenon that kills as many Americans is researched by our leading public health institutions, the CDC and NIH, leading to life-saving policy and health interventions. However, Congress has historically prohibited these research agencies from researching gun violence by refusing to allocate any dedicated federal funding over the past two decades. The House took a critical step towards changing that in June 2019, approving an appropriations bill that included \$50 million for the CDC and NIH to study gun violence.

The Senate has yet to vote on this bill.

2. Make a Call - One of the Most Effective Things You Can Do! - Scripts for calling your Senators

NOTE - You can reach your members of Congress by calling the U.S. Capitol switchboard at **(202) 224-3121**, which will connect you directly with your senators' office; or dial the member's office directly at numbers found <u>here for the Senate</u>.

Sample Script: Calling about Legislation to Strengthen Gun Laws in America

Hi,	, my name is [] and I'm a constituent of [Senator NAME], from [town/city]. I am a
	[medical student/resident/pre-med] calling to discuss the epidemic of firearm violence
	in America. In the first days of the August Recess, 19 lives were lost in El Paso, and at
	least 22 more people were shot and injured. In Dayton, 9 were killed and at least 27
	more were shot in less than 1-minute. In one day, an average of 100 Americans die
	from every-day gun violence. America is grieving, and enough is enough!

As a [medical student/resident/pre-med], I know that research is the only way to understand the root causes and treatments of health issues. I understand the importance of evidence-based solutions. And I stand in solidarity with those whose lives have been lost or affected by gun violence. I stand for the safety of my patients.

Earlier this year, a strong bipartisan majority of the House of Representatives passed a bill that appropriated \$50 million in federal funding to the CDC and NIH to research gun violence in America. **Does [Senator NAMES]**'s support this funding and what steps is he/she taking to get it signed into law?

- **If opposes funding:** How can [Senator NAME] claim to care about protecting my patients but refuse to support the very legislation that will make our communities safer? As our elected leader, it's [Senator NAME]'s responsibility to stand up for the safety of my patients and [his/her] constituents, not the gun lobby.
- If noncommittal: If [Sen NAME] is serious about keeping my patients and [his/her] constituents safe and bolstering law enforcement, I expect [him/her] to strongly support this live-saving legislation and vote for it. I'd like to hear back if [Senator] will commit to protecting our families and communities by voting in favor of these bills, please email/call me at [Insert your email address or phone number].
- **If supports funding:** Great! Thank you to [Senator NAME] for working to keep our communities safe from gun violence.





3. Share - Social Media Content to Share

NOTE - Remember to <u>include a period</u> at the beginning of your tweet if you start with a lawmakers handle.

SOME SAMPLE SOCIAL MEDIA POSTS

- .@YOUR SEN'S HANDLE: Gun violence is one of the leading causes of death and injury in the US. It's past time for the government to invest in research to study this public safety threat. Protect our patients! #EnoughIsEnough
- .@YOUR REP or SEN'S HANDLE: "Thoughts and prayers" won't stop the next shooting. What is your plan to protect my patients & community & strengthen our country's gun laws and save lives? #EnoughIsEnough
- .@YOUR REP SEN'S HANDLE: The House of Representatives has already passed several gun safety bills, from universal background checks to funding for gun violence research. Passing these bills will help protect my patients & our communities. What are you doing to demand a vote on these bills?
- .@YOUR REP or SEN'S HANDLE: 100 Americans die every day because we let dangerous people get their hands on guns. It's time for action. What is your plan to #EndGunViolence and save lives? #EnoughIsEnough
- .@YOUR REP or SEN'S HANDLE: Over 90% of Americans support background checks on every gun sale. Do you? #BackgroundChecksNow
- .@YOUR REP or SEN'S HANDLE: The NRA opposes the Violence Against Women Act because they want NO restrictions on who can have guns. They even want domestic abusers and stalkers to be able to keep their guns. I don't, what about you? Help pass #VAWA and help me protect my patients who are domestic violence survivors.
- @YOUR REP or SEN'S HANDLE: Extreme Risk Protection Orders empower law
 enforcement and family to intervene when someone shows signs of hurting themselves
 or others. Please push to pass this type of law nationwide, to protect my patients & our
 communities! #EnoughIsEnough





4. Background

Gun violence in America is a public health crisis. It is one of the leading causes of death in America. Every day, 100 people in America are shot and killed. More than 35,000 people in America die by guns every year. Gun violence costs the American economy \$229 billion every year.

Since the passage of the Dickey Amendment more than 20 years ago, the CDC and NIH have severely underfunded gun violence research. CDC funding for gun injury prevention fell by 94 percent between 1996 and 2018. In 2018, out of a total budget of more than \$8.2 billion, the CDC devoted merely \$199,000 to firearm-related research. This left public health researchers and providers in the dark as the epidemic of gun violence has grown to epic proportions in our country.

Researchers estimate that gun violence receives less than 2% of the funding it would be expected to receive based on the scope and toll of the problem. The underfunding of gun violence research is particularly stark when compared to funding for other common causes of death. The federal government spends only \$57 in research monies per gun death. By contrast, lung disease, cancer, and heart disease receive \$6,556, \$2,996, and \$1,740 per death, respectively.

A majority of Americans support efforts to increase federal funding for gun violence research. Additionally, more than 100 medical associations have called on Congress to provide funding for this research. The American people recognize that to solve this public safety crisis, we first need to understand it. It's time for our leaders to step up, take action, and fund the CDC.

Gun violence is a public health crisis in America, and there is a demonstrated need for additional research to guide policy-making. Research and data are integral to prevention, but without adequate resources, researchers are prevented from thoroughly examining gun violence and gun policies.

Medical Students for Gun Safety (MSGS) is a coalition of health professional students from across the United States dedicated to advocating for the end of gun violence in this country. Our efforts are focused on:

- (1) Promoting responsible gun ownership
- (2) Advocating for effective federal violence prevention legislation
- (3) Fighting for a better gun safety curriculum in medical education
- (4) Improving public health
