### COURSE OVERVIEW

**AMSA strives to empower physicians-in-training to effect change through education and advocacy. AMSA Scholars Programs are designed to provide medical and premed students with information not covered in traditional medical school curriculum and to foster an online learning community of future physicians.**

The AMSA Reproductive Health Scholars Program addresses the “hidden curriculum” in medical school and prepare students to think critically about abortion-related and education and training opportunities.

### GOALS AND OBJECTIVES

Students should leave this program demonstrating an understanding of:

- History of Abortion
- Basics of clinical first trimester abortion
- Basics of clinical second trimester abortion
- How to provide options counseling
- Know thyself: values clarification in abortion care
- Reproductive justice and advocacy
- Diversity & equity issues in abortion access
- Rising maternal mortality in the U.S.
- State and federal laws - their impact on access to reproductive healthcare
- Accessing abortion training when it's not offered at your medical school
- Cultural competency and sensitivity within reproductive healthcare

Student should further develop the following skills:

- Gain confidence with speaking and networking in a group
- Be able to discuss the political and historic background of abortion care, in conjunction with clinical terms and definitions
- Advocacy efforts developed through the completion of a final project

*Additional readings:* Additional readings will be suggested prior to the time of lecture that will enhance your lecture experience and understanding. Some sessions may not have pre-reading.

## COURSE REQUIREMENTS

The course is graded Pass/Fail based on the elements outlined below:

## Project Timeline

- **Project Proposal/Thesis Statement** limited to 1 page in length and should be submitted for feedback from your Course Directors by **October 13, 2022**. Group projects done by 3-4 people will be considered.

- **Final Project Outlines** should be submitted by - **December 15, 2022**.

- **Final Projects** completion date, on or before - **December 29, 2022**.
